• Bill #6: Presentation Grants (November-February) Transfer to TomProject Coro Medical Funding

- Hagemeyer- Previously discussed initiative to fund AEDs on campus with the TomProject. The bills all pertain to the same project but will be using different accounts.
- Questions:
 - Morgan- What is the basic level support training provided?
 - Hagemeyer- 20k has already been allocated from the Tom Project to Campus Recreation for CPR and AED training.
 - Morgan- How long after they're out, what is the timeline to train? Are we training Ras?
 - Hagemeyer- The University does not require RAs complete this training. The goal is to target the first few weeks when floor meetings are happening to offer classes and promote them for all students.
 - Hirsch- In an ideal world we would have one in every building, what is the process for choosing buildings?
 - Hagemeyer- This is a completely student led initiative, we decide all these plans. Ideally these AEDs will be in high traffic areas and areas where physical activity is common.
 - Creigh- if we are to pass this when would the process start?
 - Hagemeyer- Everything seems to be ready to move immediately, hoping ordering of AEDs can happen next week. Past Student Body President Levin found storage for them by the stadium and the goal would be to have them all installed by the time students come back next fall.
 - Pros:
 - Hirsch- this is a really great use of extra funds. This will have a lasting effect on our campus.
 - Sizemore- This is exactly what we want COGS to stand for. Really great initative with a lot of work put into it. Great move for COGS.
 - Graves- The endowment fund is a great idea, no point in doing this is we can't keep up with the AEDs in the future.
 - Morgan- This is an unprecedented opportunity. This is going to directly help with the consequences of the pandemic. Our ability to do this now wouldn't exist in the future as these issues arise.

Purpose & Description: FSU Childcare would like to request \$6,800 dollars for the purchase disinfecting supplies, specialized toys and supplies for children with exceptional needs and outdoor toys and equipment for the Childcare center.

The program's request addresses two categories of need: response to COVID-19 and children with exceptional needs. Working with children under 5 years old and who are unable to be vaccinated for COVID-19 requires the program to take every precaution in its response to COVID-19. The program is requesting \$2,400 in disinfecting supplies such as disinfecting wipes and spray and hand sanitizer to reduce the spread of COVID-19 in the center among infants, children, student teachers and staff. Funds, in the amount of \$2,200, for outdoor toys and equipment is being requested to create outdoor classrooms that will allow children to socially distance in a natural and well-ventilated environment. The program continues to increase the quality of services for children with exceptional needs. Funds in the amount of \$2,200 is being requested to purchase specialized toys and equipment to assist these children in meeting their fullest potential.
