

Whereas: Many graduate students at FSU are parents, guardians and/or caretakers of children in primary school;

Whereas: Many graduate students at FSU are parents, guardians, and/or caretakers of children in middle school;

Whereas: Many graduate students at FSU are parents, guardians, and/or caretakers of children in high school;

Whereas: Many graduate students at FSU are members of the LGBTQIA2S+ community;

Whereas: The Congress of Graduate Students supplies hundreds of thousands of dollars for funding the FSU Childcare and Early Learning program;

Whereas: Florida House Bill 1557 aims to prevent "classroom discussion about sexual orientation or gender identity in primary grade levels or in a manner that is not age-appropriate or developmentally appropriate for students;"

Whereas: Florida Senate Bill 1834 aims to prevent the same;

Whereas: Being a member of the LGBTQIA2S+ is nothing out of the ordinary, and to treat adults and children as such unnecessarily scandalizes people for being themselves.

Be it resolved by the 30th Congress of Graduate Students of Florida State University that: passages in Florida House Bill 1557 and 1834 which restrict and/or prevent students from discussing their sexual and/or gender identities are condemned in the strongest possible terms.

Petitions into the Assembly:

- Luis Basualdo, Seat 1 College of Social Sciences & Public Policy
 - Speech: First year MPA. I attended FSU for English, Editing Writing and Media in undergrad. I was interested in COGS because in undergrad, I did not participate in on-campus activities. During these last two years, I want to participate in campus activities. I'd like to learn more about our school and how I can be of help.
 - Questions:
 - Amareneni: What was your major?
 - Answer: Editing writing and Media and a second focus in Humanities
 - Amareneni: Did you join any on-campus activities during undergrad?

- Answer: I was part of the FSU Democrats and helped out during the Bernie campaign.
- Amareneni: Why do you want to join COGS?
- Answer: I want to take advantage of my experiences at FSU in order to better myself and my community
- Collins: What role do you see yourself playing in COGS:
- Answer: I want to improve things for students who cannot show up to school, especially in my program.
- Vaughn: Which committee would you be interested in joining?
- Answer: I want to join Student Affairs, because I feel as though I can be most present here on campus in this role and be more involved in student life.

o Pros:

- Linsky: I am motivated to fill the seats in COGS, and this puts us on a path to filling these seats.
- Rogowski: I like that he has a different point of view than other people, such as working full time. With that perspective, he will be a great fit on the student affairs committee.
- Delva: He seems dedicated to make a difference with the little time he has left on campus.
- Mustafa: I agree, he seems very dedicated and I think COGS should provide that platform to channel that energy and motivation to improve student life here at FSU.

- Andrew Goulette, Seat 3, College of Law
 - Speech: I'm a first-year law student. I was in the criminology program at FSU in undergrad. I graduated in December 2016, and following graduation, I became a school teacher. I took on a number of different roles at my school. I coached the robotics team and I was a member of the school advisory council. As far as background goes, I wanted to work after undergrad. I want to join COGS for two reasons, 1) I'm trying to find my niche outside of the law school, and 2) I would like to get my foot in the door with SGA. I'm interested in the university defender position.

Questions:

- Mustafa: How do you think your skills as a teacher will apply to COGS:
- Answer: I could handle a classroom of 36 students, and confident in management. I understand finance and budgetary concerns from my experience on the school advisory council. I am familiar with parliamentary

- procedures (e.g., Robert's Rules of Order). I also am interested in the Student Affairs Committee.
- Hagemeyer: How familiar are you with the law school council? Would you be interested in being a liason?
- Answer: I wouldn't mind, but I would like to ease into things a little bit within COGS. Do they handle budgetary concerns within COGS?
- Hagemeyer: Yes.
- Answer: Then I wouldn't mind.
- Motion to extend Q&A: Adhikari, Second: Delva
- Delva: Can you elaborate on your interest in legislative matters?
- Answer: I am interested in the judicial branch of SGA, but I'm not sure I have this interest within COGS.
- Creigh: Are you financially certified?
- Answer: I saw this is something I need to do, but I have not had time to complete the courses.
- Adhikari: How do you think COGS will help you become more involved with SGA?
- Answer: My expectation of my involvement with COGS is to have my foot in the door with SGA and to fill the third position. I would also love to get a free coffee machine for the law school.

- Linsky: I've been trying for a while to get people involved with SGA and nobody has showed up to my discussions about this. Andrew wants to be in COGS. He did his research and he reached out, and I appreciate that dedication.
