The conference will take place entirely online, with the keynote speaker and presenters delivering their papers using Zoom. The purpose of this event is multifaceted. This conference serves as essential practical experience for their RSO members who plan, organize, and execute this conference, in the process developing skills they will need while they continue to work in the field of music theory. Additionally, this conference is a recruiting tool for their graduate programs in music theory since many of the presenters and attendees of the conference will have already applied to these programs and use this event as an opportunity to continue to get to know the FSU community.

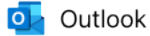

a Word Press website which hosts the call for proposals and conference details, as well as a Facebook page.

Purpose and Description: Allocating LSC Funds for the Spring 2025 Semester

Be it enacted by the Thirty-Third Congress of Graduate Students:

Section 1: The Congress finds that the process by which the Law School Council (LSC) can hear all budget requests for an entire semester and create a budget that takes all of the needs of the College of Law is a positive step in ensuring fiscal transparency and accountability in a deeply important funding board.

Section 2: The Congress acknowledges that this bill pertains only to Spring 2025 semester allocations, which do not include emergency funding allocations and disbursements made on a case-by-case basis outside of this instant process.

Section 3: The Congress hereby approves the following allocations from the Law School Council for the Spring 2025 semester to the following organizations in the following categories:
