Budget Cut Process:

- The budget was reviewed multiple times and each event was assessed one-by-one. Budget cut process looked like this:
  - Initial overview reading over paragraphs RSOs sent in and determining any trends within the budget. Comments and ideas were exchanged but nothing set in stone at the time.
  - Deliberations Determine general rules that will be applied to all RSO's budgets, except for a few exceptions.
  - Round 1 Cuts General rules applied.
  - Round 2 Cuts These were the difficult cuts that had to be made. We attempted to cut smaller amounts from each RSO in order to allow RSOs to have as much funding as possible without showing favor or bias to anyone else.
  - Exec board Review Entirety of MSC exec board reviewed suggested budgets and provided further input. Voted on final total that would be dispersed to RSOs.

AIG	Round 1 - \$700 worth of t-shirts were purchased last semester. Reduced t-shirt allocation from \$600 to \$350. Round 2 - Decreased expenses by \$100 due to limited funding.
AMA	No changes.
AMSA	Considered cutting t-shirt request since they purchased them last semester, but it was set at a high priority with fair reasoning (wanted to provide to incoming M1s during the RSO fair). No changes.
AMWA	AMWA requested one of the highest amounts due to their Women's Health Day event, which is available to not only majority graduate students, but to all of the FSU campus. Last year they held a very successful and informative event which required over 90 volunteers. AMWA requested \$1k in t-shirts to provide for their volunteers. Previous semester they used ~\$300 on t-shirts (100% of their funding).
	Round 1 - Cut a lunch & learn (\$400) in order to avoid significantly reducing funds for Women's Health Day. \$70 cut from WHD event for Publix and Amazon order. Initially, rental tents were going to be reduced from \$1,950 to \$1,650 because the vendor's website stated different prices. However, the vendor's prices vary from year to year, and in case tent rentals cost the full \$1,950, we did not want the WHD event to suffer. Round 2 - T-shirts were reduced from \$1,020 to \$800 due to limited MSC funding. Food for pizza was reduced from \$740 to \$700.

Attempted to avoid touching the HIV/AIDS Awareness Day event since it's a large event. Round 2 - Reduced food cost for HIV/AIDS Awareness Day by \$100 and contractual services by \$100 due to limited MSC funding. Late Round 2 - Cut Reproductive Health Lunch & Learn due to limited MSC funding.

WMS	Reduced expenses for camping trip. \$1000 of camping materials were purchased last semester. Cut the food to 200 due to low turnout at the last camping event.

General Rules:

- Skills night food costs maximum: \$300.
  - Previous semester, maximum was \$400.00
  - Usually skills nights are hosted in room G120 which has a max capacity of about ~30-40 people.
  - During the Spring 25 semester, there were multiple skills night events that had a significant amount of food leftover which ended up in LC refrigerators. There was a surplus of leftovers from skills nights and lunch & learns, which ended up overwhelming the fridges and going bad. We are reducing food budgets to avoid wasting food and focusing more on allocating funds for expenses in order to have the most beneficial and high quality skills nights.
  - Some of our largest RSOs' skill events spent \$150-250 on food but still held successful events with high turnouts.
    - Examples Pediatric Interest Group, Surgery Interest Group, Emergency Medicine Interest Group.
- Lunch and learn maximum increased from \$400 to \$500.
  - Lunch & Learns are usually held in the auditorium or lecture room which has a max capacity of over 100 people.
  - L&L can hold more people than skill events.
- Limited maximum events to four per RSO (not including subcommittee events).
  - Near the end of the Spring 25 semester, space on the calendar became extremely limited.
- If a collab event was listed on both RSOs' budget requests, both RSOs' collab events were cut in half to accommodate the difference.
- Cut subcommittees' budget requests to one event. The goal is not to discourage subcommittees, but was due to not having enough to fund them all. We were unable to determine a fair way to allow some RSOs' subcommittees to request funding for more than one event over another RSO, therefore every subcommittee was cut down to one event.
  - Subcommittees are still encouraged to host more events if there is leftover funding from their RSOs.
- Our initial plan was to not allow RSOs to purchase more t-shirts if they already purchased them last semester (Spring 25). However, due to multiple RSOs requesting for more t-shirts (the \$525 limit from last semester allowed most RSOs to purchase around 35-40 t-shirts), we decided to allow them to budget for more.
  - Limit per semester was set at \$550.
    - \*\*\*RSOs were allowed to use more funds toward t-shirts when they were no longer able to host or plan for events at the end of the semester.
  - Limit per year is ~\$1,000-\$1,100.
    - The \$100 variability depended on whether our fiscal budget could afford it and how much the RSO requested overall.
  - For example, an RSO purchased \$600 of t-shirts last semester and requested \$550 for the upcoming semester. Instead of cutting it completely, we reduced the allocation to ~\$400-450.

# Summary of Legislation:

Pursuant to the 2025-2026 Budget Proviso, I write to you to notify you that I have made the following allocations, totaling **\$3,554**, out of the Speaker's Request account:

- 1. Iranian Student Association (New Line Item: "Tigran Celebration") \$1,056 in Food. **TOTAL: \$1,056.** 
  - a. Tigran is an annual celebration in the early summer among Iranians. COGS has provided funding for this event in each of the last two years.
  - b. Due to the timing of ISA's event and the requirement for COGS to wait until the start of the new fiscal year before making budgetary changes, it was impractical to bring an allocation bill to the Assembly and get the funding to the organization in time.
- Civil and Environmental Engineering Graduate Student Association (CEEGSA) (New Line Item: "Career and Research Fair") - \$933 in Food, \$1,565 in Clothing & Awards. TOTAL: \$2,498.
  - a. CEEGSA is hosting a new Career and Research Fair at the College of Engineering in late July and is seeking COGS funding.
  - b. Similar to ISA, the odd timelines related to the fiscal year make it necessary to fund the event through the Speaker's Request.

A bill will be presented to COGS at the July 7<sup>th</sup> meeting asking the Assembly to reimburse the Speaker's Request account for the expense due to the allocations taking up nearly forty percent of the account.

# COGS Bill/Resolution #: 23

Sponsor(s): Speaker Rowan

Short Title: The Congressional Organizational Session Act of 2025

# Summary of Legislation:

The bill amends Chapter 111 of COGS Code to establish organizational sessions at the start of each Congress to elect officers. The bills makes conforming changes to Chapter 117 of COGS Code to relocate language establishing the order of seniority when necessary to assume the chair at COGS meetings.

## **Background Information:**

During the 2024-2025 Constitutional Review Commission, discussions began about implementing a series of organizational sessions for the Student Senate and COGS to each elect their leadership prior to fall inauguration. The Commission approved a proposed amendment that would place the Senate's organizational session in the Student Body Constitution.

The Florida Legislature currently holds an organizational session within two weeks of a general election in order to elect the officers of each body, establish rules of procedure, and complete other housekeeping business.

# Effect of Proposed Legislation:

The bill requires that, no later than two weeks after the Fall SGA elections, the Supervisor of Elections certify the results of all COGS elections that do not have outstanding violations or contests. The bill provides the form for such certifications.

The bill would require that the Speaker call an organizational session at least two weeks after the fall elections. At this organizational session, the Congress would elect a Speaker, as well as several of the Deputy Speakers.

The bill further lays out a more formalized process for the election of a Speaker, including a requirement that candidates declare their candidacy through written form submitted to the

sitting Speaker and affirming that they intend to serve the entirety of their term. The bill provides the contents of such a form, which is attached (in final form) as Attachment #2.

The election process for Deputy Speakers will not change, as a result of this bill, except that the elections will take place at the organizational session and that candidates for the office of Deputy Speaker for Finance will be required, prior to accepting their nomination, to affirm that they are willing and able to serve the entirety of the term they are being elected to.

Section 2 reinserts language from Chapter 111 into Chapter 117 that defines who the most senior member of the Congress is and how seniority should be tracked.

Short Title: Adopting a New Seal and Logo for the Congress of Graduate Students

## Summary of Legislation:

The Resolution adopts a new seal and logo for the Congress of Graduate Students. The Resolution further provides some guidelines around the use of the seal and logo to ensure brand consistency.

## **Background Information:**

In June 2024, COGS was informed that its original logo violated FSU branding guidelines due to the use of the University Seal's flames in the design. As a result, the Congress had to use a temporary logo for the 2024-2025 school year on all merchandise and official university communications.

During the 33<sup>rd</sup> Congress, Speaker Rowan tasked Deputy Speaker Baez with developing a new design for the COGS logo. (NOAH, FILL IN WITH YOUR WORK)

# Effect of Proposed Legislation:

The Resolution, as it stands, does not adopt a design for the new COGS seal and logo. The Congress needs to amend the Resolution to choose either Exhibit A or Exhibit B as the adopted design. Once the Congress amends the Resolution to include one of the designs, the Resolution will adopt such design as the seal and logo for the Congress.

The Resolution also lays out some basic guidelines for the use of the seal and logo. The seal (which will only be comprised of the chosen design) is for official uses, such as authenticating COGS documents or signaling COGS's approval of an agreement, as deemed necessary by members of the Executive Committee. Additionally, the seal may be used for purposes agreed to by the Speaker or by resolution of the Congress.

The logo (which will include alternative logos that reflect the traditional color schemes [Garnet & White; Gold & White; and Black & White] used by COGS in the past) is simply used to represent COGS in all non-official capacities.

The distinction between the seal and logo are fairly minor and simply provides a legislative basis for the Congress to use and require a seal for certain documents.
