Representative Wyckoff: Good evening everyone, This bill allocates **\$14,736** from COGS Reserves to the **Indian Student Association of Tallahassee**, also known as INSAT. The funding will support two of their largest annual cultural events — **Diwali** and **Holi**. These events are major celebrations that engage both graduate and undergraduate students, promoting cultural exchange and community engagement across campus. The budget covers food and event expenses for both celebrations, with **\$6,470** for Diwali food, **\$96** for Diwali expenses, **\$7,010** for Holi food, **\$840** for Holi expenses, and **\$320** for joint event costs, totaling **\$14,736**. These are some of INSAT's biggest events of the year, drawing large attendance and contributing greatly to campus diversity and inclusion. I'm happy to take any questions about the amount or the budget breakdown

Powermill Climber

- One of the most popular forms of cardio currently at the Leach Center.
- Frequently a line of students waiting to use on our 6 current climbers.
- Pricing: \$10,000 per unit



Iso-Lateral Incline Press

- The Leach Center currently has no options for plate loaded push exercise equipment.
- Push exercises include chest, triceps, shoulder press type lifts.
- Pricing: \$3,000 per unit



Iso-Lateral Bench Press

- Another plate loaded push option.
- An alternative to the flat bench press that frequently in use during peak times.
- Pricing: \$3,000 per unit



Iso-Lateral Decline Press

- Another plate loaded push option.
- Targets the lower part of the chest.
- Currently no similar options in the Leach Center.
- Pricing: \$3,000 per unit





Plate-Loaded Hack Squat

- Currently only one option in the Leach Center, frequently in use.
- Current model is old and outdated.
- Pricing: \$5,000 per unit

Sponsor(s): Deputy Speaker Baez & Representative Lamb

Short Title: Establishing the International Coffee Hour: Graduate Lounge as a Recurring Event

Summary of Legislation:

This bill allocates funding and formalizes the partnership between the Center for Global Engagement (CGE) and the Congress of Graduate Students (COGS) to host the International Coffee Hour: Graduate Lounge twice per semester. The event promotes conversation, connection, and networking among FSU graduate students in an inclusive and welcoming environment.

Background Information:

The first International Coffee Hour: Graduate Lounge, co-hosted by CGE and COGS, successfully brought together graduate students from diverse academic and cultural backgrounds to foster community and cross-cultural dialogue. Due to its positive reception and strong participation, both CGE and COGS have agreed to make this event a recurring initiative held twice each semester. The collaboration supports COGS' mission to enhance the graduate student experience through engagement, community building, and inclusivity. Stakeholders involved include CGE, COGS, and the broader FSU graduate student community.

Effect of Proposed Legislation:

This legislation establishes the International Coffee Hour: Graduate Lounge as a recurring COGS-supported event and ensures continued funding for its implementation each semester. By institutionalizing the event, COGS will provide ongoing opportunities for graduate students to connect across disciplines and cultures, strengthening the sense of community within the FSU graduate population.

COGS Resolution #: 10

Sponsor(s): Speaker Rowan

A RESOLUTION

Amending Rule 3 of COGS Internal Rules of Procedure

1 **WHEREAS**, the recodified COGS Code includes language regulating quorum for the Assembly and its
2 committees; and

3 **WHEREAS**, Rule 3 of COGS IROP has contradictory language; and

4 **WHEREAS**, the provisions of Rule 3 limit the bills considered at the meeting where the Annual Budget
5 is proposed; and

6 **WHEREAS**, the last two Budget Nights, the rule has been suspended to allow the consideration of
7 legislation tied to the budget; and

8 **WHEREAS**, amendments to the COGS IROP are necessary to correct these two issues;

9 **NOW, THEREFORE, BE IT RESOLVED by the 33rd Congress of Graduate Students at Florida**
10 **State University that:** Rule 3 of COGS IROP is hereby amended to read:

11 **Rule 3: Meetings Of The COGS Assembly**

12 1. The COGS Assembly shall meet in regular session on the first and third Monday of each
13 month at 6:30 PM in the FSU Senate Chambers, unless the time or place of the meeting is
14 otherwise specified by the Speaker no less than twenty-four (24) hours before the meeting.
15 Representatives living outside of Leon County, Florida, may appear by virtual means.

16 2. Special meetings of the Assembly may be called by the Speaker, with the endorsement
17 of two other members of the Executive Board, or by petition of two-thirds of the COGS
18 membership. All special meetings require twenty-four (24) hour notice to members and the
19 public.

20 (a) Any member seeking a special meeting shall notify the Speaker and Advisor by
21 filing a petition for the special meeting. Such petition must state the date, time, and
22 location of the meeting, and the topics for said meeting.

- 23 (b) Upon receipt of a petition, the Advisor or Speaker shall poll the COGS
24 membership to determine whether the required number of members are in favor of the
25 meeting. Such a poll shall occur without unnecessary delay.
- 26 (c) Should two-thirds of the members be in favor of the special meeting, it shall be
27 immediately noticed to all members and the public.
- 28 3. ~~No action may be taken at any meeting of the Assembly or its committees unless a~~
29 ~~quorum is present, except for a motion to adjourn.~~
- 30 4. The Agenda of each meeting shall be as follows:

- 71 6. The Speaker shall have the authority to reorder the Agenda at their discretion, or to

- 74 subject to a majority (50% plus 1) vote of the Assembly present.
- 75 8. The Speaker, in consultation with the Deputy Speaker for Finance, shall have the
- 76 authority to designate items as "Budget Implementing and Conforming Business," to be heard
- 77 in the specified section of the agenda set out in Rule 3.5, if they believe that the item is
- 78 necessary to implement the budgetary decisions of the Congress or to conform the COGS
- 79 Code to the budgetary decisions of the Congress. A representative may raise a point of order
- 80 that the item is improperly designated under this section. Upon such a point being raised, the
- 81 Speaker shall put the following question: "Should the item be designated as an item
- 82 implementing the Budget or conforming the Code to the Budget?" The item shall remain on the
- 83 agenda only by majority vote in the affirmative to the aforementioned question.
